### DESCRIPTION

Concentrated, probiotic-based cleaner for washable surfaces and floors. Promotes general well-being by installing a natural, protecting microflora. Using PolVita Protective Indoors as a daily cleaner ensures effective and continuous cleaning against dirt, and ensures the elimination of bad odors. Fresh minty fragrance.

### USAGE

- **Surfaces:** pour into a bucket or spray on modern surfaces, desk tops, laminated surfaces, washable and enamelled paints, telephones, screens, fingerprints on doors, maintenance of contact points (door latches, switches).  
Spray onto the surface to be cleaned or clean with a microfibre soaked with the solution. Leave to dry. For switches, it is recommended to apply the product with a piece of paper or with a microfiber for safety reasons.
- **Floors:** for all forms of manual application, use a double bucket, flat mop or swab.

### DOSAGE

- Bucket: 0.4%. (1 dose/5L). 0.8% in case of heavy soiling (2 doses)
- Spray: 3% (1 dose/650ml spray)

*Pollet does not advise using probiotic cleaners in certain limited hospital areas: high and very high-risk zones (zone 3 and 4).*

### TECHNICAL CHARACTERISTICS

- Scent: mint
- Colour: blue
- pure pH:  $7 \pm 0.5$
- pH in solution of 0.4%:  $7 \pm 0.5$
- pH in solution of 0.8%:  $7 \pm 0.5$
- pH in solution of 3%:  $7 \pm 0.5$
- Does not alter the protective treatments in any way, whatever the form of application

### STORAGE AND CONSERVATION

- Deadline for use of the concentrated version: 24 months under normal storage conditions.
- Deadline for use of the diluted version: 2 weeks under normal storage conditions.
- Store the product in its original sealed packaging. Do not allow to freeze.
- A slight deposit may appear.
